

**ROSE TOWNSHIP
REGULAR MEETING
JUNE 14, 2021**

The Rose Township Board held their regular meeting June 14, 2021. Meeting was opened by Supervisor Aaron Gemmill with the pledge to the flag at 7:00 pm.

ROLL CALL OF OFFICERS: Present – Kelli Collins, Aaron Gemmill, April Kangas, Amber Kreiner, Shelley Maleski. Absent – None.

MINUTES: Minutes of the last regular meeting were approved. **Motion by Kangas to accept the minutes as read. Second Kreiner. Motion voted and carried.**

PUBLIC COMMENT: Jenny from the City of Rose City was present to discuss the City as organizer for the Fireworks and asking for the boards continued support.

COMMITTEE REPORTS:

Cemetery – Bid received from J & Sons for removal of 7 trees at the cemetery. **Motion by Kangas to accept the bid for \$2100 for removal of 7 trees at Lane Heights Cemetery. Second Maleski. Motion voted and carried.**

Collection Center – Maleski stated free dump day closed before noon due to containers being full. Republic was unable to provide drivers and a compact truck due to staff shortages. Free dump day was extended to the next weekend to try to accommodate anyone who was unable to utilize it due to the early closing. Maleski suggested we get bids from other waste collection contractors due to lack of communication with Republic and their services.

Township Hall – Cement in pavilion area is fixed. Will wait until next year to do landscaping. The Yard Butler submitted a bid for \$50 to mow the horseshoe pit. The Yard Butler will also spray for weeds at the township hall for \$100 which includes all supplies.

Park – Bid received from J & Sons for tree removal of a Maple in the amount of \$1000. **Motion by Kreiner to accept the bid for \$1000 for tree removal from J & Sons. Second Kangas. Motion voted and carried.**

Fire Department – Fire trucks are being repaired. They are reviewing a cost recovery ordinance from another department to review.

Roads – Nothing.

MTA – Principles of Governance received and signed.

Library – Nothing.

County Commissioner – Nothing.

Litter and Zoning – Rose Township Junk and Garbage Ordinance copy to everyone. This was adopted in 1998. Board will review and revisit next month.

Collins advised MML Property Insurance renewal increased by \$142 due to 2% property inflation. However our annual dividend return is \$266.

Bills were read by Collins in the amount of \$32,973.11 beginning with voucher number #31121 through voucher number #31154. **Motion by Kangas to pay all bills as read. Second Kreiner. Motion voted and carried.**
