If you are unsure if your summer tax bill has been paid, please call me. Unpaid summer tax bills, plus penalty, are still payable to Rose Township until Feb. 28, 2011.

**Monday, Feb. 28th, 2010** This will be the last day to pay Summer & Winter Taxes at the Township. The Hall will be open 9:00 a.m. to 5:00 p.m. February 28<sup>th</sup> postmarks will also be honored.

**On March 1, 2010** Penalty and interest applied to all unpaid taxes and are now due and payable to the Ogemaw County Treasurer's Office in West Branch. Their phone number is: 989-345-0084.



Dog Licenses will be available for purchase after December 1<sup>st</sup>. They can be purchased at the Township Hall on the scheduled tax collection days or from the Ogemaw County Treasurer's Office.

**If you have received a license renewal form from the County, please bring it with you when purchasing new license.**

\$10.00 for Spayed/Neutered Dogs

\$15.00 for Male/Female Dogs

**After March 1<sup>st</sup>, the license fee will be \$30.00 for all dogs and only available from the Ogemaw County Treasurer's Office. In order to issue you a license, we must see proof of a current rabies vaccination. Renewals can be accepted without rabies certificate if renewal form shows vaccination as current.**
