If you are unsure if your summer tax bill has been paid, please check online or call me. Unpaid summer tax bills, plus interest, are still payable to Rose Township until Feb. 29th, 2016.

This tax season I will be collecting taxes at the Rose Township hall on two Saturdays in December & February. The hall is located at: 3380 Lupton Road in Lupton. Dates and hours are listed below.

**The Township Hall will be open from 9:00 a.m. to 12:00 p.m. on these Saturdays:**

**December 12<sup>th</sup> & 19<sup>th</sup> and February 13<sup>th</sup> & 20<sup>th</sup>**

**On Wednesday, Dec. 30<sup>th</sup> and Monday, Feb. 29<sup>th</sup> the Township Hall will be open from 9:00 a.m. to 5:00 p.m.**

**Monday, Feb. 29<sup>th</sup>, 2016** This will be the **last day** to pay Summer & Winter Taxes at the Township. The Hall will be open 9:00 a.m. to 5:00 p.m. Feb. 29<sup>th</sup> postmarks will also be honored. **On March 1, 2016** Penalty and interest applied to all unpaid taxes and are now due and payable to the Ogemaw County Treasurer's Office in West Branch. Dog Licenses will be available for purchase after December 1<sup>st</sup>. They can be purchased at the Township Hall on the scheduled tax collection days or from the Ogemaw County Treasurer's Office.

**If you have received a license renewal form from the County, please bring it with you when purchasing new license.**

\$10.00 for Spayed/Neutered Dogs

\$15.00 for Male/Female Dogs

**After Feb. 29<sup>th</sup>, the license fee will be \$30.00 for all dogs and only available from the Ogemaw County Treasurer's Office. In order to issue you a license, we must see proof of a current rabies vaccination. Renewals can be accepted without certificate if renewal form shows vaccination as current.**
