ABSENTEE BALLOT NOW

ABSENT VOTER BALLOT - ANY registered voter is eligible to obtain an absentee ballot for an upcoming election. A voter who wishes to receive an absentee ballot must request it in writing from the clerk; absentee ballots may not be delivered as a result of an oral request made in person or over the phone. However, an absentee ballot application form may be provided as a result of an oral request. The Township Hall will be open from 9:00 a.m. to 12:00 p.m. on these Saturdays:

December 7th & 21st and February 22nd & 29th

On Tuesday, Dec. 31st and Monday, March 2nd the Township Hall will be open from 9:00 a.m. to 5:00 p.m.

Note: If there is inclement weather, please contact me at the hall to ensure that we are open. The phone number at the hall is 989-473-2001. If no answer, call 989-685-8047.

Monday, March 2nd, 2020 is the last day to pay Summer & Winter Taxes at the Township. The Hall will be open 9:00 a.m. to 5:00 p.m. **March 2nd** postmarks will also be honored. **On March 3rd, 2020** Penalty and interest applied to all unpaid taxes and are now due and payable to the Ogemaw County Treasurer's Office, P.O. Box 56, West Branch, MI 48661. Their phone number is: 989-345-0084.

Recycling Information  We accept #1, #2, #4, #5 & #7 plastics, glass, tin & aluminum containers, paper, magazines, newspaper and cardboard. **Please make sure items are rinsed out, clean & break down all cardboard boxes to save space in the bins.** More information & details are available online.



Dog Licenses will be available for purchase after December 1st. They can be purchased at the Township Hall on the scheduled tax collection days or from the Ogemaw County Treasurer's Office. **If you have received a license renewal form from the County, please bring it with you when purchasing new license.**

\$10.00 for Spayed/Neutered Dogs

\$15.00 for Male/Female Dogs

After March 3rd, the license fee will be \$30.00 for all dogs and only available from the Ogemaw County Treasurer's Office. In order to issue you a license, we must see proof of a current rabies vaccination. NOTE: Renewals can be accepted without certificate if renewal form shows vaccination as current.
