Dog Licenses will be available for purchase after December 1st. They can be purchased at the Township Hall on the scheduled tax collection days or from the Ogemaw County Treasurer's Office. **If you have received a license renewal form from the County, please bring it with you when purchasing new license.**

\$10.00 for Spayed/Neutered Dogs

\$15.00 for Male/Female Dogs

After March 2nd, the license fee will be \$30.00 for all dogs and only available from the Ogemaw County Treasurer's Office.

In order to issue you a license, we must see proof of a current rabies vaccination. Renewals can be accepted without certificate if renewal form shows vaccination as current.
